Are there services covered before you meet your deductible?	No.	You will have to meet the deductible before the plan pays for any services.
Are there other deductibles for specific services?	Yes. For <u>prescription drugs</u> - Individual \$150 / Family \$450. Doesn't apply to Tier 1A & generic drugs. There are no other specific <u>deductibles</u> .	You must pay all of the costs for these services up to the specific <u>deductible</u> amount before this plan begins to pay for these services.
What is the <u>out-of-pocket limit</u> for this plan?	In- <u>Network</u> : Individual \$3,000 / Family \$6,000.
